Every chapter places students in roles as practitioners handling simulated law practice problems; provides a doctrinal overview; includes exercises, visual aids, and questions to guide student reading; and includes materials that help students reflect on their professional roles. In addition to Supreme Court decisions, materials include differing circuit court applications of doctrine, jury instructions, oral arguments, briefs, expert reports, and other practical documents. The text provides factual context by including background about the work of prison guards, police, and social workers.

*Current Issues in Constitutional Litigation* could be used for 2, 3, or 4-credit course or for a Section 1983 constitutional clinic.

The Teacher's Manual includes banks of multiple-choice and essay questions and answers and teaching guides for exercises and law practice simulations. This casebook is designed to make it easier to implement the ideas in the Carnegie Foundation's *Educating Lawyers* (2007) and *Best Practices for Legal Education* (2007) by integrating the teaching of doctrine and skills and using multiple methods of instruction.
